# Monday, May 23, 2022

### Bill voted on Third Consideration:

<u>SB 1043</u> (STEFANO) Amends the Steel Products Procurement Act to allow more options for documentation submissions. PASSED 47-0.

### Bill amended on Third Consideration and voted on Supplemental Calendar:

<u>SB 848</u> (MENSCH) Amends Act 218 of 1905 by creating the position of Chief Nursing Officer of the Commonwealth within the Department of Health. <u>AMENDED AND PASSED 35-12.</u>

<u>A04197</u> (MENSCH) Adds a provision requiring the chief nursing officer to have at least 5 years of experience providing direct care to patients. <u>AGREED TO.</u>

### Bills voted on Supplemental Calendar:

<u>SB 230</u> (PHILLIPS-HILL) Amends the Taxpayer Relief Act, in senior citizens property tax and rent rebate assistance, to clarify the definition of income. <u>PASSED 47-0.</u>

**SB 1186 (GORDNER)** Amends Title 75 (Vehicles) to allocate a portion of the fee for USA Semiquincentennial Registration Plates to the U.S. Semiquincentennial Commission for activities **PASSED 47-0.** 

# **Tuesday, May 24, 2022**

### **Bills voted on Third Consideration:**

<u>SB 622</u> (PITTMAN) Amends Title 71 (State Government) to expand the definition of "enforcement officer" within the State Employees' Retirement Code. **PASSED 45-0.** 

**SB 1038 (STEFANO)** Amends the Surface Mining Conservation and Reclamation Act to redirect certain monies for the purpose of paying for alternative bonding system legacy sites. **PASSED 30-15.** 

**SB 1163 (YUDICHAK)** Amends the State Lottery law to provide for confidentiality of certain prizewinner identities. **PASSED 45-0.** 

<u>HB 1560</u> (STEPHENS) Designates the U.S. Air Force Major James Doherty Memorial Highway in Bucks County and provides for omnibus designations. <u>PASSED 45-0.</u>

## **Bills amended on Third Consideration:**

HB 723 (MIZGORSKI) Amends the Workforce Development Act to bring it into compliance with federal law as provided for in the Workforce Innovation and Opportunity Act (WIOA) of 2014. OVER AS AMENDED.
A03672 (BARTOLOTTA) Clarifies language. AGREED TO.

### Bill amended on Third Consideration and voted on Supplemental Calendar:

<u>HB 2051</u> (KAUFER) Authorizes DGS to convey or lease numerous Commonwealth properties and eliminates deed restrictions on previously conveyed properties. <u>AMENDED AND PASSED 45-0.</u>

A04175 (YUDICHAK) Adds additional land conveyances. AGREED TO.

# Wednesday, May 25, 2022

#### Bill voted on Third Consideration:

<u>HB 889</u> (B. MILLER) Amends the Professional Nursing Law, further providing for examinations and certificates regarding international nurses. **PASSED 47-0.** 

### Resolution voted on Supplemental Calendar:

**SR 230 (BROWNE)** Establishes a temporary rule of the Senate relating to amendments to the General Appropriation Bill and other appropriation bills for the fiscal year beginning July 1, 2022. **PASSED 47-0.**
