## A RESOLUTION

- 1 Proposing special rules of practice and procedure in the Senate 2 when sitting on impeachment trials.
- 3 RESOLVED, That the Senate of Pennsylvania adopt special rules
- 4 as follows:
- 5 Rules of Practice and Procedure
- in the Senate When Sitting On
- 7 Impeachment Trials
- 8 Section 1. Reception of managers.
- 9 (a) Subject to subsection (b), when the Senate receives
- 10 notice from the House of Representatives that it has appointed
- 11 managers to conduct and prosecute an impeachment against an
- 12 individual and has directed the managers to carry articles of
- 13 impeachment to the Senate, the Secretary of the Senate shall
- 14 immediately inform the House of Representatives that the Senate
- 15 is ready to receive the managers for the purpose of exhibiting
- 16 such articles of impeachment, agreeably to such notice.
- 17 (b) If notice under subsection (a) is received when the

- 1 Senate has adjourned for at least ten days, the President pro
- 2 tempore shall immediately appoint a committee under section 10.
- 3 Section 2. Exhibition of articles of impeachment.
- 4 (a) When the managers are introduced at the bar of the
- 5 Senate and signify that they are ready to exhibit articles of
- 6 impeachment against an individual, the presiding officer shall
- 7 direct the Sergeant at Arms to make a proclamation.
- 8 (b) The Sergeant at Arms shall, after making the
- 9 proclamation, repeat the following words: "All persons are
- 10 commanded to keep silence, on pain of imprisonment, while the
- 11 House of Representatives is exhibiting to the Senate of
- 12 Pennsylvania articles of impeachment against
- 13 (c) The articles of impeachment shall be exhibited.
- 14 (d) The presiding officer shall inform the managers that the

. "

- 15 Senate will take proper order on the subject of the impeachment
- 16 and will give notice to the House of Representatives.
- 17 Section 3. Consideration.
- 18 (a) Upon presentation of articles of impeachment to the
- 19 Senate, the Senate shall proceed to consider the articles.
- 20 (b) Consideration shall begin:
- 21 (1) 1 p.m. on the day following presentation;
- 22 (2) if presentation is on a Sunday, at 1 p.m. on the
- 23 Tuesday following presentation; or
- 24 (3) the time and day ordered by the Senate.
- 25 (c) After consideration begins, unless the Senate orders
- 26 otherwise, the Senate shall continue in session every day except
- 27 Sunday until final judgment is rendered and no further
- 28 consideration is needed.
- 29 (d) Before consideration, the oath or affirmation shall be
- 30 administered to the presiding officer and by the presiding

- 1 officer to each Senator then present and to other Senators as
- 2 they shall appear on the floor. A Senator has the duty to take
- 3 the oath or make the affirmation. The oath or affirmation must
- 4 be in the form set forth in section 25(c).
- 5 Section 4. Issuance of orders, etc.
- 6 The presiding officer may issue orders, writs and precepts
- 7 authorized by these rules or by the Senate, and may make and
- 8 enforce other rules and orders in the Senate Chamber as the
- 9 Senate authorizes.
- 10 Section 5. Enforcement.
- 11 (a) The Senate has the following powers:
- 12 (1) To compel the attendance of witnesses.
- 13 (2) To enforce obedience to its orders, mandates, writs,
- 14 precepts and judgments.
- 15 (3) To preserve order and to punish in a summary way
- 16 contempts of, and disobedience to, its authority, orders,
- mandates, writs, precepts or judgments.
- 18 (4) To issue lawful orders and rules which it deems
- 19 essential or conducive to the ends of justice.
- 20 (b) The Sergeant at Arms, under the directions of the
- 21 Senate, may employ aid and assistance necessary to execute and
- 22 enforce the lawful orders, mandates, writs and precepts of the
- 23 Senate.
- 24 Section 6. Preparation and form of proceedings.
- 25 (a) The President pro tempore shall direct:
- 26 (1) necessary preparations in the Senate Chamber; and
- 27 (2) the form of proceedings.
- 28 (b) The presiding officer shall rule on all questions of
- 29 evidence, including relevance, materiality and redundancy of
- 30 evidence and incidental questions. Except as set forth in

- 1 subsection (c), a ruling under this subsection shall stand as
- 2 the judgment of the Senate.
- 3 (c) On a ruling under subsection (b), a vote may be taken as
- 4 follows:
- 5 (1) A Senator may request a formal vote on the ruling.
- 6 (2) The presiding officer may submit the ruling for a
- 7 vote.
- 8 (3) Upon request under paragraph (1) or submission under
- 9 paragraph (2), the vote shall be taken under the Rules of the
- 10 Senate immediately. Debate is not permitted.
- 11 (4) The result of the vote shall stand as the judgment
- of the Senate.
- 13 Section 7. Writ of summons.
- 14 (a) Upon presentation of articles of impeachment and the
- 15 organization for consideration under these rules, a writ of
- 16 summons shall issue to the individual impeached.
- 17 (b) The writ must contain all of the following:
- 18 (1) A recitation of the articles.
- 19 (2) Notice to the individual to:
- 20 (i) appear, personally or by counsel, before the
- 21 Senate at a specified time, on a specified date and at a
- 22 specified location;
- 23 (ii) file an answer to the articles; and
- 24 (iii) stand to and abide the orders and judgments of
- 25 the Senate on the articles.
- 26 (c) All of the following apply to service of the writ:
- 27 (1) The officer or individual named in the precept of
- 28 the writ shall execute service.
- 29 (2) Service must be executed within the advance notice
- 30 specified in the precept.

- 1 (3) Service must be executed in one of the following
- 2 manners:
- 3 (i) By delivery of an attested copy of the writ to the individual impeached.
- (ii) If delivery under subparagraph (i) cannot conveniently be done, by leaving an attested copy of the writ in a conspicuous place at the last known place of residence or the usual place of business of the individual impeached.
- 10 (iii) If the Senate determines that compliance with
  11 subparagraphs (i) or (ii) is impracticable, in a manner
  12 the Senate deems just.
- 13 (d) Upon compliance with subsection (b)(2), the individual 14 impeached may:
- 15 (1) Plead guilty. Upon entry of the plea, judgment shall be rendered.
- 17 (2) Plead not guilty. Upon entry of the plea, trial shall commence.
- (e) Upon noncompliance with subsection (b)(2)(i) or (ii), a
- 20 plea of not guilty shall be entered. Upon entry of the plea,
- 21 trial shall commence.
- 22 Section 8. Return of summons.
- 23 At 12:30 p.m. on the day appointed for the return of the
- 24 summons against the individual impeached:
- 25 (1) The legislative and executive business of the Senate
- shall be suspended.
- 27 (2) The Secretary of the Senate shall administer an oath
- or affirmation to the returning officer in the following
- 29 form:
- 30 I, , do solemnly swear or affirm that the

- 1 return made by me upon the process issued on the day
- of , by the Senate of Pennsylvania, against ,
- is truly made, and that I have performed such
- 4 service as therein described: (So help me God).
- 5 (3) The oath or affirmation shall be entered on the
- 6 record.
- 7 Section 9. Appearances.
- 8 The appearance or nonappearance of the individual impeached,
- 9 either personally or by counsel shall be recorded on the record.
- 10 Section 10. Committee.
- 11 (a) In an impeachment trial, unless otherwise ordered by the
- 12 Senate, the President pro tempore may appoint a committee of
- 13 Senators, no more than half of whom must be members of the same
- 14 political party. The President pro tempore shall be an ex
- 15 officio member and may vote in case of a tie on any question
- 16 before the committee.
- 17 (b) The functions of the committee are to receive evidence
- 18 and take testimony at times and places determined by the
- 19 committee. To discharge these functions, unless otherwise
- 20 ordered by the Senate, the committee and its chairperson have
- 21 the powers and duties conferred upon the Senate and the
- 22 President pro tempore or the President of the Senate,
- 23 respectively, under these rules.
- 24 (c) Upon appointment, the President pro tempore shall be
- 25 responsible for setting the first meeting of the committee.
- 26 Thereafter, the committee shall meet on such days as the
- 27 committee chair may decide until the committee has determined
- 28 that all relevant testimony and evidence has been presented.
- 29 (d) A ruling regarding the admissibility of evidence shall
- 30 be made by the committee chair subject to a right of appeal to

- 1 the committee. In an appeal, the committee shall vote on the
- 2 admissibility of the contested evidence.
- 3 (e) Unless otherwise ordered by the Senate, these rules
- 4 shall govern the procedure and practice of the committee so
- 5 appointed.
- 6 (f) The committee shall report to the Senate in writing that
- 7 it has completed receiving evidence and taking testimony, and
- 8 the committee shall provide a summary of the evidence and
- 9 testimony and a certified copy of the transcript of the
- 10 proceedings and testimony had and given before such committee.
- 11 (g) The report under subsection (f) shall be received by the
- 12 Senate and the evidence received and the testimony taken shall
- 13 be considered, subject to the right of the Senate to determine
- 14 competency, relevancy and materiality, as having been received
- 15 and taken before the Senate.
- 16 (h) Nothing in this section shall prevent the Senate from
- 17 sending for a witness and hearing the witness's testimony in
- 18 open Senate. The Senate may receive additional evidence and
- 19 testimony before making its final judgment on the articles of
- 20 impeachment.
- 21 Section 11. Commencement of trial.
- 22 Unless otherwise ordered by the Senate, at 12:30 p.m. on the
- 23 day appointed for the trial of an impeachment:
- 24 (1) the legislative and executive business of the Senate
- shall be suspended; and
- 26 (2) the Secretary of the Senate shall give notice to the
- 27 House of Representatives that the Senate is ready to proceed
- upon the impeachment in the Senate Chamber.
- 29 Section 12. Time of trial.
- 30 Unless the Senate orders otherwise, trial of an impeachment

- 1 shall begin each day at 12 noon. At that time, a proclamation
- 2 shall be made; and the trial shall proceed. Adjournment of the
- 3 trial does not operate as an adjournment of the Senate.
- 4 Section 13. Record.
- 5 The Secretary of the Senate shall record the proceedings in
- 6 cases of impeachment as in the case of legislative proceedings,
- 7 and the proceedings shall be reported in the same manner as the
- 8 legislative proceedings of the Senate.
- 9 Section 14. Counsel.
- 10 Counsel for the parties shall be admitted to appear and be
- 11 heard on impeachment. Counsel must be admitted to practice law
- 12 by a court of record of this Commonwealth.
- 13 Section 15. Presentation of questions, etc.
- 14 A motion, objection, request or application, whether relating
- 15 to the procedure of the Senate or relating immediately to the
- 16 trial, including questions with respect to admission of evidence
- 17 or other questions arising during the trial, made by the parties
- 18 or their counsel shall be addressed to the presiding officer
- 19 only. The presiding officer or a Senator may require a written
- 20 submission and reading by the Secretary of the Senate.
- 21 Section 16. Witnesses.
- 22 Witnesses shall be examined by one individual on behalf of
- 23 the party producing them, and then cross-examined by one
- 24 individual on the opposing side.
- 25 Section 17. Senator as witness.
- 26 If a Senator is called as a witness before the full Senate,
- 27 the Senator shall testify at the Senator's desk on the floor of
- 28 the Senate.
- 29 Section 18. Actions by individual Senators.
- 30 (a) If a Senator wishes a question to be put to a witness,

- 1 to a manager or to counsel of the individual impeached, or to
- 2 offer a motion or order, except a motion to adjourn, it must be
- 3 reduced to writing and shall be put by the presiding officer.
- 4 (b) The parties or their counsel may interpose objections to
- 5 a witness answering a question propounded at the request of a
- 6 Senator. The merits of the objection may be argued by the
- 7 parties or their counsel. Ruling on the objection shall be made
- 8 under section 6(b) and (c).
- 9 (c) It is not in order for a Senator to engage in colloquy
- 10 under this section.
- 11 Section 19. Session to be open.
- 12 (a) Subject to subsection (b), when the Senate is sitting
- 13 upon the trial of an impeachment, the doors of the Senate shall
- 14 be kept open.
- 15 (b) The Senate may direct the doors to be closed while
- 16 deliberating upon its decisions. A motion to close the doors may
- 17 be acted upon without objection. If an objection is raised to
- 18 the motion, the motion shall be voted on without debate by roll
- 19 call vote, entered on the record.
- 20 Section 20. Argument time limits.
- 21 Unless the Senate otherwise orders, preliminary or
- 22 interlocutory questions or a motion, or both, shall be argued
- 23 for not exceeding one hour on each side.
- 24 Section 21. Presentation of case.
- 25 (a) The case for impeachment shall be opened by a statement
- 26 of one manager or counsel for the managers.
- 27 (b) The case against impeachment shall be opened by a
- 28 statement of the individual impeached or one counsel
- 29 representing the individual.
- 30 (c) Unless otherwise ordered by the Senate upon application:

- 1 (1) The case against impeachment shall be closed by
- 2 argument on the merits made by no more than two of the
- 3 following:
- 4 (i) The individual impeached.
- 5 (ii) Counsel for the individual impeached.
- 6 (2) The case for impeachment shall be closed by argument
- 7 on the merits made by no more than two individuals in the
- 8 following categories:
- 9 (i) The managers.
- 10 (ii) Counsel for the managers.
- 11 Section 22. Voting on articles of impeachment.
- 12 (a) An article of impeachment is not divisible for the
- 13 purpose of voting on the article during the trial.
- 14 (b) Once voting has commenced on an article of impeachment,
- 15 voting shall be continued until voting has been completed on all
- 16 articles of impeachment unless the Senate adjourns for a period
- 17 not to exceed one day or adjourns sine die.
- 18 (c) On the final question whether the impeachment is
- 19 sustained, the vote shall be taken on each article of
- 20 impeachment separately.
- 21 (d) If impeachment upon an article is not sustained by the
- 22 votes of two-thirds of the Senators present, a judgment of
- 23 acquittal on that article shall be entered on the record.
- 24 (e) If impeachment upon an article is sustained by the votes
- 25 of two-thirds of the Senators present, the Senate shall proceed
- 26 to the consideration of other matters determined to be
- 27 appropriate; and a judgment of conviction on that article shall
- 28 be entered on the record. A certified copy of the judgment shall
- 29 be transmitted to the Secretary of the Commonwealth.
- 30 (f) A motion to reconsider the vote by which an article of

- 1 impeachment is sustained or not sustained is not in order.
- 2 (g) To put the question on each article of impeachment:
- 3 (1) the presiding officer shall state the question; and
- 4 (2) by roll call vote entered on the record, each
- 5 Senator shall rise in place and answer guilty or not guilty.
- 6 Section 23. Votes on orders or decisions.
- 7 (a) An order or decision may be acted upon without
- 8 objection.
- 9 (b) If an objection is raised to an order or decision,
- 10 subject to subsection (c) and section 6(b) and (c), all of the
- 11 following apply:
- 12 (1) Except as set forth in paragraph (2), the motion or
- decision shall be voted on without debate by roll call vote.
- 14 (2) A motion to adjourn may be decided without a roll
- call vote unless a roll call vote is demanded by one-fifth of
- 16 the Senators present.
- 17 (3) The vote shall be entered on the record.
- 18 (c) When the doors of the Senate are closed for
- 19 deliberation, all of the following apply to an objection to an
- 20 order or decision:
- 21 (1) Subject to paragraph (2), all of the following
- apply:
- 23 (i) No Senator may speak more than once on one
- 24 question.
- 25 (ii) No Senator may speak for more than ten minutes
- on a question.
- 27 (iii) No Senator may speak for more than 15 minutes
- on the final question. The 15 minutes allowed under this
- subparagraph is on the whole deliberation of the final
- question, and not on the final question on each

- individual article of impeachment.
- 2 (2) A time period under paragraph (1) may be altered if,
- 3 upon motion and without debate, the Senate consents.
- 4 Section 24. Oath or affirmation of witnesses.
- 5 (a) A witness must be sworn in the following form:
- 6 I, , do swear (or affirm, as
- 7 the case may be) that the evidence I shall give in the
- 8 case now pending between the Commonwealth of Pennsylvania
- 9 and , shall be the truth, the whole truth, and
- nothing but the truth: (So help me God).
- 11 (b) The oath shall be administered by the Secretary of the
- 12 Senate or another authorized person.
- 13 Section 25. Forms.
- 14 (a) The following is the form of a subpoena to be issued on
- 15 the application of a manager or of the individual impeached or
- 16 the individual's counsel:
- 17 To , greeting:
- 18 You and each of you are hereby commanded to appear before
- 19 the Senate of the Commonwealth of Pennsylvania, on
- 20 the day of , at the Senate Chamber in the
- 21 city of Harrisburg, then and there to testify your
- 22 knowledge in the cause which is before the Senate in

- 25 Witness , and (President or President pro
